## **Campus Placement Policy**

- To be eligible for placements, a student should have minimum aggregate of 6 CGPA and above without any backlogs apart from satisfying the criteria specified by the recruiting organization/ company.
- A student aspiring to go for higher education either in INDIA or abroad or choose any other career options, has to give in writing at the beginning of 5<sup>th</sup> semester that he / she is not interested in sitting for placements.
- 3. Students must attend all the training programs conducted by SGCSRC. A minimum of 80% attendance is required as eligibility criteria to participate in placements drives.
- 4. A student with a track record of indiscipline will be disqualified from campus placement process.
- 5. All the students who get selected in a company will not be allowed to appear for the subsequent placement drives. However, those students who get selected in IT service companies will be given a second chance to appear for respective core Sector Companies, provided the compensation offered is more than that of IT service company.
- 6. At any point of time all the students eligible for placements shall appear for all the selection processes (on & Off campus). However, an eligible student can withdraw from the placements drive not more than two times on his/her own (based on health reasons) with prior intimation and approval. Students who are absent beyond two times will get disqualified for all the subsequent campus placements,
- 7. All the students who are shortlisted in the preliminary screening test conducted by the company shall attend the subsequent stages of the selection process. Any defaulter thereafter will be disqualified from further campus placements.
- 8. The students shall attend the recruitment process in placement uniform only.
- 9. The selected students are expected to improve their <u>academic and professional competency</u> till they join the company. <u>Further, after the completion of the graduation, the notification of the onboarding process is at the discretion of the company.</u>
- 10. A student selected in campus placements will have an obligation to honour the offer given by the company to sustain the relation with the companies. All the selected students shall give an undertaking accordingly.
